| Citation and Commencement | 1. This Regulations may be cited as the Mining (Special) Regulations 2005, and shall come into effect on the 23 rd March 2005. |
| Interpretation | 2. In these Regulations "Commission" shall mean the Guyana Geology and Mines Commission |
| Application | 3. These Regulations shall apply only for the purposes of and in relation to the application for Mining Permits and Prospecting Licences over the areas as described in the Schedules hereunder and to the extent only as set out in these Regulations. |
| Application for Mining Permits | 4. In relation to the areas set out in Schedule 1, these shall be subject to public auction to be held on the 23 rd day of March, 2005. All further logistical information shall be provided by the Commission in the daily newspapers. |
| Application for Prospecting Licences | 5. In relation to the areas set out in Schedule 11, these shall be subject to public auction to be held on the 23 rd day of March, 2005. All further logistical information shall be provided by the Commission in the daily newspapers.. |
| | 6. Subsequent to the aforesaid auctions all applications for grant of permits and licences, as the case may be, shall be made within six weeks of the date of the auction. |
| | 7. Failure to comply with the application procedures as provided for under the Mining Act, 1989, and Regulations, shall result in the award being considered to have lapsed. |

BHP Closed Area
